Michigan Spatial Reference Network (MSRN)

Real Time Correction Message User Agreement (AGREEMENT) for the Use and Access of Data.

GENERAL

The Real Time Correction Broadcasts in Radio Technical Commission for Maritime Services (RTCM) format via a single connection to the system per the AGREEMENT for stations which are a part of the MSRN system is offered to you, the user ("User"), as a public service. You should read the following to understand the limitations regarding the information provided and the use to be made of these RTCM broadcasts.

Government personnel and the general public may use this system to retrieve RTCM Messages. A User may not:

- 1) Knowingly and without authorization, alter, damage, or destroy the Michigan Department of Transportation ("MDOT") or another user's computer system, network, software, program, documentation or data contained therein;
- 2) Use this service to conduct or attempt to conduct any business or activity or solicit the performance of any activity that is prohibited by law. In addition, taking action which results in blocking access to this IP address by other users will be deemed an unauthorized use and may subject the User to law enforcement action.

This system uses administrative monitoring of Users accessing the system.
